| Cigna* | HMO Referral/POS, PPO Rx | Varies – verification of benefits required |
| Coventry Health Care | HMO Referral/POS, PPO Rx | Varies – verification of benefits required |
| Department of Labor/OWCP | Auth required for services & hearing devices | 100% benefit for device & supplies when approved |
| GEHA* | RX | Varies – verification of benefits required |
| IWIF | Auth required for services & hearing devices | 100% benefit for device & supplies when approved |
| John Hopkins Health Care Network/EHP/USFHP | Auth required for services & hearing devices | Varies – verification of benefits required |
| Mailhandlers* | RX | Follows Medicare guidelines when supplement to Medicare – no benefit |
| MAMSI* | RX | Varies – verification of benefits required |
| MDIPA* | Referral unless MDIPA Preferred | Varies – verification of benefits required – State employees up to \$1400 |
| Medicare | RX | No Benefits |
| NALC* | RX | Varies – verification of benefits required |
| Optimum Choice* | Referral unless OCI Direct | Varies – verification of benefits required- State employees up to \$1400 |
| PHCS* | RX | Varies – verification of benefits required |
| Tricare/Health Net Federal Services (Non-Network Provider) | RX | Benefits available |
| United Healthcare* (Excludes MD State funded plan) | RX | Varies – verification of benefits required MD State Employees – Up to \$1000 per ear every 36 months |

*Per carrier's policy reimbursement is only made for a standard unit, any dollar amount above the cost of a standard unit is the responsibility of the member/patient.
